Dear Mr. Mesa-Tejada:


This letter serves as my expressed written permission for you to enter onto Hampstead Middle School property on February 2, 2016 and March 8, 2016 for the sole purpose of exercising your right to vote and participate in the annual town election process. Please find attached school district policy KFA which outlines the expectations for your conduct while on school property.

The No Trespass Order issued to you on January 15, 2016, and all of its directives relating to school district property, shall remain in effect until such time as I provide written notification to rescind in full.

Please take note that this is the second occasion in less than one year that your behavior has been disruptive to the operations of the school district. I ask that in the future you consider fully the well-being of our students, staff and community members before you make comment on matters relating to the school district. You, yourself described your most recent comments about shooting students as "inexcusable" to which many, including myself, agree. Prior to this event, the Middle School principal was compelled to issue you a letter of reprimand for the way in which you spoke so rudely to the students and staff members in the building. Be advised that we will continue to work with the appropriate authorities to ensure the safety of our students and staff members.

The School Board will review this No Trespass Order at one of their future meetings. We will update you should there be a change in status.

PUBLIC CONDUCT ON SCHOOL PROPERTY

For purposes of this policy, “school property” means school buildings, District buildings not being used as a school, vehicles used for school purposes, any location during a school athletic and other school-sponsored event, and school grounds.

Visitors are welcome on school property, provided their presence will not be disruptive. All visitors must initially report to the Building Principal’s office. Any person wishing to confer with a staff member must contact that staff member by telephone to make an appointment. Conferences with teachers are held outside school hours or during the teacher’s conference/preparation period.

The School District expects mutual respect, civility, and orderly conduct among all individuals on school property or at a school event. No person on school property or at a school event shall:

1. Injure, threaten, harass, or intimidate a staff member, a School Board member, sports official or coach, or any other person;
2. Damage or threaten to damage another’s property;
3. Damage or deface School District property;
4. Violate any New Hampshire law, or town or county ordinance;
5. Smoke or otherwise use tobacco products;
6. Consume, possess, distribute, or be under the influence of alcoholic beverages or illegal drugs, or possess dangerous devices or weapons;
7. Impede, delay, disrupt, or otherwise interfere with any school activity or function (including using cellular phones in a disruptive manner);
8. Enter upon any portion of school premises at any time for purposes other than those that are lawful and authorized by the School Board;
9. Operate a motor vehicle in a risky manner or in violation of an authorized District employee’s directive;
10. Violate other District policies or regulations, or an authorized District employee’s directive.

Any person who violates this policy or any other acceptable standard of behavior may be ordered to leave school grounds.

Additionally, the District reserves the right to issue “no trespass” letters to any person whose conduct violates this policy, acceptable standards of conduct, or creates a disruption to the school district’s educational purpose.
